

## INFORMATION ON PERSONAL DATA PROCESSING

*Following the article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons concerning the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) (Official Journal of the EU L.2016.119.1) (hereinafter: GDPR), the Jagiellonian University (JU) informs that:*

1. The administrator of your data is the Jagiellonian University, ul. Gołębia 24, 31-007 Kraków.
2. Data Protection Officer appointed by the Jagiellonian University is based at ul. Czapskich 4, 31-110, room no. 27, Kraków. The Officer can be contacted via e-mail: [iod@uj.edu.pl](mailto:iod@uj.edu.pl) or by phone – 12 663 12 25.
3. Your personal data will be processed in order to:
  - a) perform a contract of donation for purposes indicated by the law and the JU Statute regarding the JU own scholarship funds – as provided by Article 6.1(b) of the GDPR;
  - b) execute the legal duties imposed on the Administrator with regard to the received donation – as provided by Article 6.1(c) of the GDPR;
  - c) pursue Administrator's legitimate interests including determination, pursuit or defence of possible claims under the performance of a contract, as provided by Article 6.1(f) of the GDPR;
  - d) publish your name and surname by the Jagiellonian University on the Own Scholarship Funds benefactors' list at the JU Centre for Academic Support websites ([stypendia.uj.edu.pl](http://stypendia.uj.edu.pl)), as well as in the promotional materials for the JU Own Scholarship Funds based on your consent – as provided by Article 6.1(a) of the GDPR;
  - e) convey information by means of electronic communication or traditional mail based on your consent – as provided by Article 6.1(a) of the GDPR.
4. Providing your personal data is a prerequisite for purposes related to the conclusion and performance of the above-mentioned contract and executing the duties imposed on the Administrator. Not providing the personal data will result in lack of concluding and performing the contract. In case of the data mentioned in point 3(d) and 3(e) above, consent for processing the personal data on above-mentioned purpose is completely voluntary.
5. Your personal data may be made available to institutions and organs authorised to collect them pursuant to the generally applicable law, and to entities processing personal data on the Administrator's request in connection with a task they are entrusted to perform.
6. In case of having given the consent mentioned in point 3(d) above, the data will be made available to all the users visiting the websites of the JU Centre for Academic Support ([stypendia.uj.edu.pl](http://stypendia.uj.edu.pl)), and having access to the promotional materials for the JU Own Scholarship Funds.
7. Your personal data will be processed for the period required to perform the contract, and for the period required for determination, pursuit or defence of possible claims, and

subsequently for a period of archiving the documentation, and – in case of the data processed on the basis of consent – until the consent is withdrawn.

8. You have the following rights: to obtain information on personal data processing and rights resulting from the GDPR, to access your data and rectify them, as well as to have them deleted from the controller's database (unless further processing is necessary for fulfilling a legal obligation or for the purposes of determining, pursuing, or defending claims), to limit their processing or transfer, and to object to the processing of the data – in the cases and under the conditions specified in the GDPR.
9. Within the scope of the personal data processing based on your consent, you have the right to withdraw your consent at any time, which will not affect the processing performed before the consent had been withdrawn. You may withdraw your consent by sending an email to the e-mail address: [fundusze.stypendialne@uj.edu.pl](mailto:fundusze.stypendialne@uj.edu.pl), or with traditional mail to the address: Scholarships Office – the JU Centre for Academic Support, R. Ingardena 6, room 1.06, 30-060 Krakow, or withdraw it in person, having visited the JU Scholarships Office to the above-mentioned address. In case of data mentioned in point 3(d) above, withdrawal of the consent will result in having your personal data deleted from the JU Own Scholarship Funds benefactors' list at the JU Centre for Academic Support websites ([stypendia.uj.edu.pl](http://stypendia.uj.edu.pl)) and from the promotional materials for the Own Scholarship Funds. Concerning the data mentioned in point 3(e) above, the consequence of the consent withdrawal will be having your personal data deleted from the contact databases and ceasing to receive the information by the JU.
10. Your personal data will not be subject to automated decision-making nor used for profiling.
11. You have the right to lodge a complaint to the President of the Personal Data Protection Office, if you believe that the processing of your personal data violates the GDPR provisions.
